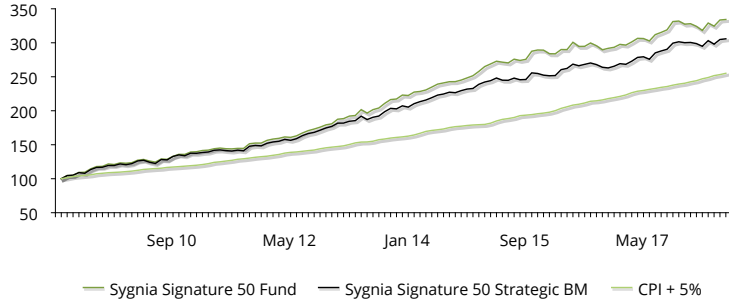

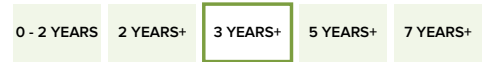

## INVESTMENT APPROACH

The Sygnia Signature 50 Fund is a low to medium risk multi-asset-class global balanced portfolio. The underlying investments are allocated to a number of specialist asset managers, both active and passive, appointed and selected by Sygnia based on their skills, experience, performance and operational and financial soundness. The aim of the Fund is to offer investors access to a well-diversified global balanced portfolio that utilises the best asset managers in their fields, while ensuring that the risk profile of the strategy remains consistent over time.

## BALANCING RISK AND REWARD

The Sygnia Signature 50 Fund is suitable for investors seeking modest inflation-beating returns with a lower volatility of monthly returns. The Fund is also suited to investors who aim to maximise capital accumulation without placing their accumulated capital at substantial risk of short-term losses. The strategy complies with Regulation 28 of the Pension Funds Act and is therefore suitable for investors in retirement annuities, preservation funds, pension funds and provident funds.

The recommended investment term for investors in the Sygnia Signature 50 Fund is a minimum of three- to five-years. The Fund has a low to medium risk profile as it has a 50% strategic allocation to domestic and global equities. The risk in the Fund is managed by spreading investments across asset classes, as well as among a number of different asset management houses. The former ensures diversification of sources of returns over market cycles, while the latter ensures diversification of investment styles and philosophies in the manner in which the assets are managed. Tactical asset allocation is used to take advantage of short-term mispricing opportunities in the market in an efficient and cost-effective manner and as a risk management tool in times of market downturns.

## FEES

Sygnia charges an annual management fee comprised of applicable basic fees paid to underlying managers and Sygnia's annual service fee.

Sygnia Life has agreed performance fees with certain of the underlying managers. These performance fees are designed to encourage and reward performance by the investment manager in excess of agreed performance benchmarks with the objective of enhancing the overall portfolio returns and increasing the likelihood of the portfolio achieving its return objectives.

Fees are quoted exclusive of performance fees. To the extent that the fund is invested in underlying hedge funds or international fund of funds it may result in a higher fee structure. Fees charged by underlying managers are treated as an expense of the account.
